

# Media Advisory – Sacramento County Youth Detention Facility Is Top 10 Finalist in National Contest

**Sacramento, CA – July 17, 2017**

**WHAT:** Residents in the Sacramento County Youth Detention Facility's Boys & Girls Club participated in a national Boys & Girls Club contest. Their entry, a video describing how the Boys & Girls Club has impacted their lives, has been selected as one of ten finalists out of 112 submissions. Voting to determine the winner of the contest began on Tuesday, August 15, 2017, at 7:00 a.m. PST and ends on Monday, August 21, 2017, at 11:59 p.m. PST.

The Grand Prize winner will receive \$10,000 to help fund its neighborhood Boys & Girls Club; a private Skype session with famed American ballet dancer, Misty Copeland; and \$1,500 in Dr. Pepper/Snapple gear. Runners-up will receive unspecified cash amount for their neighborhood Boys & Girls Club and Dr. Pepper/Snapple gear.
