SUMMARY OF MINUTES

June 16th, 2021

CALL TO ORDER: The meeting convened via Zoom video conference at 8:44 a.m. Commissioner Dennis Dulay welcomed participants.

Approval of May 19th, 2021 Meeting Minutes

Report from Probation

- ACPO Maria Gonzalez shared that there has been an increase in population at YDF due to more serious offenses being committed.
- Additionally, residents are still waiting to be transported to DJJ due to a backlog at DJJ.
- There has been a decrease in girls at YDF.

ACPO Maria Gonzalez and Interim Chief Marlon Yarber left the meeting at 9:02am.

Report from the Court:

- Judge Borack shared that there is new legislation in Illinois regarding restorative justice in juvenile courts.
- Sarah Davis shared that the Court is working on how to re-open to the public. There are currently remote appearances for the morning calendars and trials are in person as needed. Sarah will be discussing with probation to find a place to hold the JJDPC meeting in person for the July meeting.

Standing Committee Reports:

- Nominations: Commissioner Fred Mills has nothing new to report at this time.
- Inspections: Commissioner Jane Claar requested team leaders reach out to new members for sign ups. Commissioner Heyman Matlock volunteered to be the team lead for Central Patrol.

New Business

- Nominations for Chair and Vice Chair: Commissioner Fred Mills shared that Dennis Dulay has agreed to continue as Chair for the next year. He also shared that Jane Claar and Harold Rowe agreed to serve as co-Vice Chairs for the next year.

- Commissioner handbooks will be copied and distributed to new Commissioners with Commissioner Dulay's approval.
- Strategic Plan: Dennis Dulay shared that the strategic plan should focus on lack of services at YDF as well as STRTPs. Commissioners Claar, Rowe, and Hunter volunteered to be the facilitators for the creation and drafting of the Strategic Plan. They will present a general plan for the next three to five years at the July meeting.
- Website: Harold Rowe shared that he is waiting to hear from all the Commissioners regarding updated bios for the website. Once bios are collected, the website will be updated.
